

NOTICE OF BASTROP COUNTY ELECTION PRECINCT BOUNDARY CHANGES

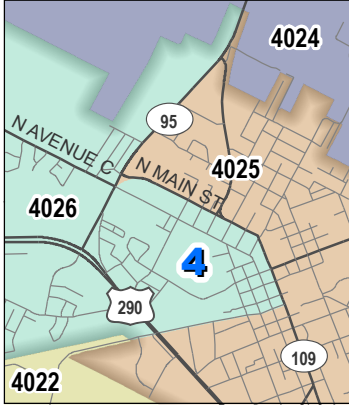
NOTICE IS HEREBY GIVEN OF A BOUNDARY CHANGE IN BASTROP COUNTY ELECTION PRECINCTS. Pursuant to an order of Bastrop County Commissioners Court on November 22, 2021, in accordance with Chapter 42 of the Texas Election Code, the Commissioners Court approved the realignment of County Election Precincts to conform to the newly revised and adopted boundaries of the four County Commissioners Precincts, as reflected in the maps below. These changes are to become effective January 1, 2022. A map showing the amended County Election Precincts is attached hereto as Exhibit 1. More detailed maps of the County Election Precincts in each County Commissioner Precinct are attached hereto as Exhibits 2 through 5. Recintos, como se refleja en los mapas a continuación. Estos cambios entrarán en vigencia el 1 de enero de 2022.
