


ORDER APPROVING THE COUNTY TREASURER'S MONTHLY REPORT

At a regular meeting of the Commissioners' Court of Bastrop County, Texas, held on the 22nd day of June 2020, on a motion made by Commissioner and seconded by Commissioner \_\_\_\_\_, the following order was adopted:
